KEYHOLDERS ARE FULL MEMBERS

PILLIONS ARE ASSOCIATED TO KEYHOLDER MEMBERS

NO OTHER RANKS EXISTS, ROAD CAPTAIN / SECRETARY ARE ONLY POSITIONS USED BY CHAPTER PRESIDENT WHEN AND IF NEEDED. ALL OTHER RANKS TO BE REMOVED ON CUTS.

- ONLY RANK BEARERS MAY DISPLAY THE CHAPTER NAME ABOVE RANKS, RANKS AND CHAPTER NAMES STAYS THE PROPERTY OF DOW AND MUST BE HANDED IN AFTER COMPLETION.
- VETERANS WILL BE DISTINGUISHED BY THEIR UNIT BADGE AND A PIN, REST ARE ALL NOBLES.

CUTS AND WHAT IS ALLOWED ON IT

LEFT SIDE

- LEFT TOP IS NEW DOW AFFILIATION PIN.
- BELOW DOW AFFILIATION PIN IS BROTHERHOOD PIN/S.
- LEFT BELOW BROTHERHOOD PIN/S IS BUDDY PROJECT BADGE.
- LEFT UNDER ARM IS GBNF ROCKER.
- MILITARY RIBBON BARS OF THE VETERAN MAY BE DISPLAYED UNDER THE DOW DOG TAG ON THE LEFT CHEST.
- LEFT LOWER IS ALL DOW PARTICIPATING PINS ONLY IE. GELOFTEDAG, BUDDY RUN, ECT.

RIGHT SIDE

- RIGHT TOP IS MILITARY/DOW PROFICIENCY IF APPLICABLE.
- RIGHT CHEST IS CHAPTER NAME TOP FOR RANK BEARERS ONLY, RANK MIDDLE AND SURNAME BOTTOM TAGS.
- RIGHT LOWER IS MILITARY UNIT BADGE/VETERAN PIN, IF APPLICABLE, OR NOBLE BADGE.
- RIGHT LOWER IS ALL NON DOW PARTICIPATING PINS, NON OFFENSIVE, NON POLITICAL OR BADGES FROM OTHER CLUBS.
- RIGHT DOWN LOW BLOOD GROUP IF NEEDED.
- BACK IS RESERVED FOR THE 3 PIECE PATCH SET – TOP AND BOTTOM ROCKER AND CENTRE BADGE, NOTHING ELSE!

PROSPECTS

- PROSPECTS TO ONLY USE BUDDY PROJECT TAG ,GBNF ROCKER (LEFT SIDE)
- PROSPECT TAG (RIGHT SIDE)
- BACK, DOGS OF WAR AND WE SERVED ROCKERS WITHOUT AFRICA PORTION DURING PROSPECT TIME OF 3 MONTHS. AFTER PROSPECT TIME GET FULLY PATCHED (CENTRE BADGE, DOGS PIN & BROTHERHOOD PIN, NAME,UNIT BADGE/NOBLE BADGE)
- CUT ONLY TO BE WORN WHEN RIDING BIKE AND AT FUNCTIONS (AS INDICATED BY NATIONAL OR CHAPTER PRESIDENT), NOT IN VEHICLES (T-SHIRTS OR ANY OTHER DOW BRANDED CLOTHING MAY BE WORN.)
- CUT NOT TO BE TAKEN OFF DURING FUNCTIONS OR MEETINGS.
- CUT NOT TO BE WORN WITH SHORT TROUSERS, NO CLOTHING OR SHIRTS THAT LOOKS INNAPROPRIATE OR TOPLESS.
- HELMET AND CUT NEVER TO BE PLACED ON GROUND OR BAR COUNTER, OR ANY PLACE WHERE IT IS IN DISRESPECT TO PATCH.
- NEVER GET DRUNK, FIGHT, USE DRUGS OR MISBEHAVE WITH CUT ON ANYWHERE!
- NO OPEN SHOES MAY BE WORN WHEN WEARING YOUR CUT.

FINANCE

- ALL KEYHOLDERS TO PAY NOMINAL YEARLY MEMBERSHIP FEES TO NATIONAL ON DATE BY END FEBUARY LATEST (R250.00).
- PILLIONS, ASSOCIATED OR HONOURABLE MEMBERS DO NOT PAY MEMBERSHIP FEES AS THEY DON'T HAVE ANY VOTING RIGHTS.
- ALL CHAPTERS TO HAVE A BANK ACCOUNT OF WHICH ALL DETAILS AS REQUESTED BE GIVEN TO NATIONAL TREASURER ON TIME.
- CHAPTERS MAY GET DONATIONS, HOLD RUNS, HOLD JOLS, ECT. AS LONG AS NATIONAL PRE APPROVED, AND THEN ROYALTIES TO BE PAID (15% TO NATIONAL FOR USING NAME AND TRADEMARK OF DOW, TREASURER TO DISCUSS).
- CHAPTERS ARE NOT ALLOWED TO FORCE ANY OTHER FEES FROM MEMBERS, AND ALL DONATIONS MUST BE VOLUTARY.
- ALL FUNDS IN NATIONAL AND CHAPTER ACCOUNTS ARE ONLY TO BE USED IN AID OF VETERANS, ANYTHING ELSE MUST FIRST BE APPROVED BY NATIONAL.

DOW SHOP

- DOGS OF WAR PATCH AND OR EMBLEM IS TRADE MARKED AND MAY ONLY BE USED BY SHOP OR WHERE WRITTEN AUTHORIZATION IS OBTAINED FROM NATIONAL, AND THE ROYALTIES WILL BE APPLICABLE AS NEGOTIATED BY TREASURER.
- DOW HAS AN ONLINE SHOP AS WELL AS SHOP AT DOW FUNCTIONS.
- ALL ITEMS IN SHOP WHERE DOW PATCH ARE ON BACK, ARE ONLY TO BE WORN BY DOW MEMBERS/PILLIONS AND NOT PUBLIC AS IT CONSTITUTES OUR PATCH.
- IF CHAPTERS ORDER AND BUY LARGE STOCK FOR CHAPTER, DISCOUNTS WILL BE GIVEN THAT CAN BE USED FOR CHAPTER FUNDING.
- NO CHAPTER OR MEMBER MAY BE IN COMPETITION WITH DOW SHOP IN RESPECT TO THE CLOTHING SOLD IN THE SHOP OR THE USE OF LOGOS OR DESIGNS (INCL. FUTURE DESIGNS IN ANY MANNER OR WAY WHATSOEVER).

HOW TO BECOME A MEMBER/PILLION

- THERE IS A RIDE ALONG PERIOD OF MINIMUM 3 MONTHS WHEREBY THE CHAPTER AND PERSON CAN SEE IF THE RELATIONSHIP CAN WORK, AND IN THAT TIME THE APPLICATION FEES AND PATCH FEES CAN BE SAVED FOR, NO APPLICATION OR PAYMENT DURING THE RIDE ALONG PERIOD TO BE PAID OR HANDED IN AT ALL.
- AFTER RIDE ALONG, THE CHAPTER PRESIDENT WILL REQUEST BY VOTE FROM CURRENT CHAPTER MEMBERS TO ALLOW FOR PROSPECT PERIOD TO BEGIN IF NOT A 100% VOTE THE RIDE ALONG PERIOD CAN BE EXTENDED, ONCE VOTE IS OBTAINED THEN APPLICATION CAN BE GIVEN TO THE PERSON, ONLY THEN WILL MONEY TO BE PAID TO NATIONAL, AND APPLICATION SEND TO TREASURER AFTER SIGNED BY

CHAPTER PRESIDENT, THIS STARTS THE PROSPECT THREE MONTH PERIOD.

- AFTER THE THREE MONTH PROSPECT PERIOD, THE CHAPTER PRESIDENT WILL REQUEST BY VOTE FROM CURRENT CHAPTER MEMBERS TO ALLOW FOR FULL PATCHING. IF NOT A 100% VOTE THE PROSPECT PERIOD CAN BE EXTENDED UNTIL A 100% VOTE IS OBTAINED.
- SHOP WILL SEND PROSPECT PATCH TO CHAPTER PRESIDENT AFTER TREASURER CONFIRMED PAYMENT, THEN STARTS THE 3 MONTHS NOT NEGOTIABLE PROSPECTING TIME, AFTER WHICH THE REST OF THE PATCH WILL BE SENT TO CHAPTER PRES AFTER HIS CONFIRMATION OF COMPLETION OF PROSPECT PERIOD IS GIVEN.
- NO PATCHES TO BE OBTAINED DIRECTLY FROM ANY SUPPLIER AT ALL!
- BOTH PROSPECT AND FULL PATCH PATCHING TO BE ORGANISED BY CHAPTER PRESIDENT.
- DOW PATCH, ROCKERS, RANKS AND CHAPTER NAMES IS THE SOLE PROPERTY OF DOGS OF WAR, AND MUST BE HANDED IN AFTER RESIGNATION, DISCIPLINARY ACTION, NO REFUND AND OR DISCUSSION, IT STAYS THE PROPERTY OF DOW FOR EVER.

MEMBERS

- ONLY KEYHOLDERS ARE FULL MEMBERS, PILLIONS ARE ASSOCIATED AND ATTACHED TO A KEY HOLDER.
- HONOROURY MEMBERS ARE ONLY ALLOWED BY NATIONAL, BUT THEY HAVE NO VOTE AND ONLY ALLOWED TO WEAR PATCH/JACKET AT DOW FUNCTIONS AS A HONOURARY MEMBER (THEY ARE NOT ALLOWED TO REPRESENT THE DOW AT ANY STAGE IN ANY FORMAL CAPACITY).

DISCIPLINARY ACTIONS AND POWERS

- NATIONAL SERGEANT AT ARMS AND CHAPTER SERGEANTS AT ARMS ARE RESPONSIBLE FOR DISCIPLINE AND SECURITY AT ALL LEVELS TOGETHER WITH THE PRESIDENTS.
- ALL INTERNAL CHAPTER DISCIPLINARY ACTIONS TO BE TAKE BY CHAPTER PRESIDENT WITH HIS SERGEANT AT ARMS ON A FAIR AND UNBAISED BASIS.
- CHAPTER PRESIDENTS MAY REPRIMAND, SUSPEND AND OR GIVE PENALTY IF PERSON FOUND GUILTY, BUT ALL RECORDS AND PROOF MUST BE AVAILABLE TO NATIONAL, AND ALL MEMBERS CAN APPEAL TO NATIONAL IF APPROVED BY NATIONAL SERGEANT AT ARMS.
- ONLY NATIONAL CAN TAKE PATCHES AWAY, LABEL SOMEONE AS UNDESIRABLE OR PUT SOMEBODY IN BAD STANDING AND IF LAY CRIMINAL CHARGES, THEREFORE IF NEEDED THESE CASES MUST BE HANDLED BY NATIONAL SERGEANT AT ARMS.
